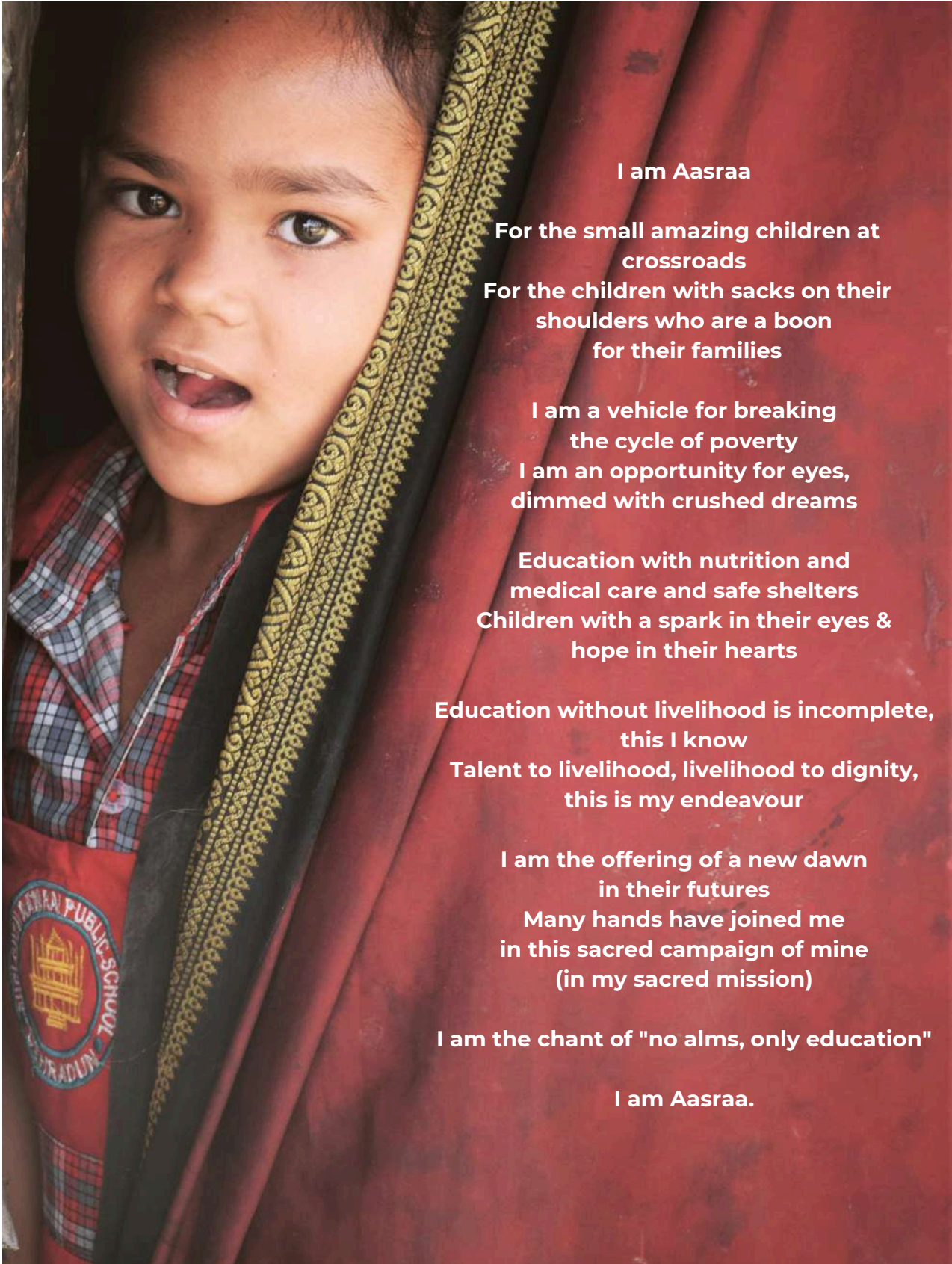

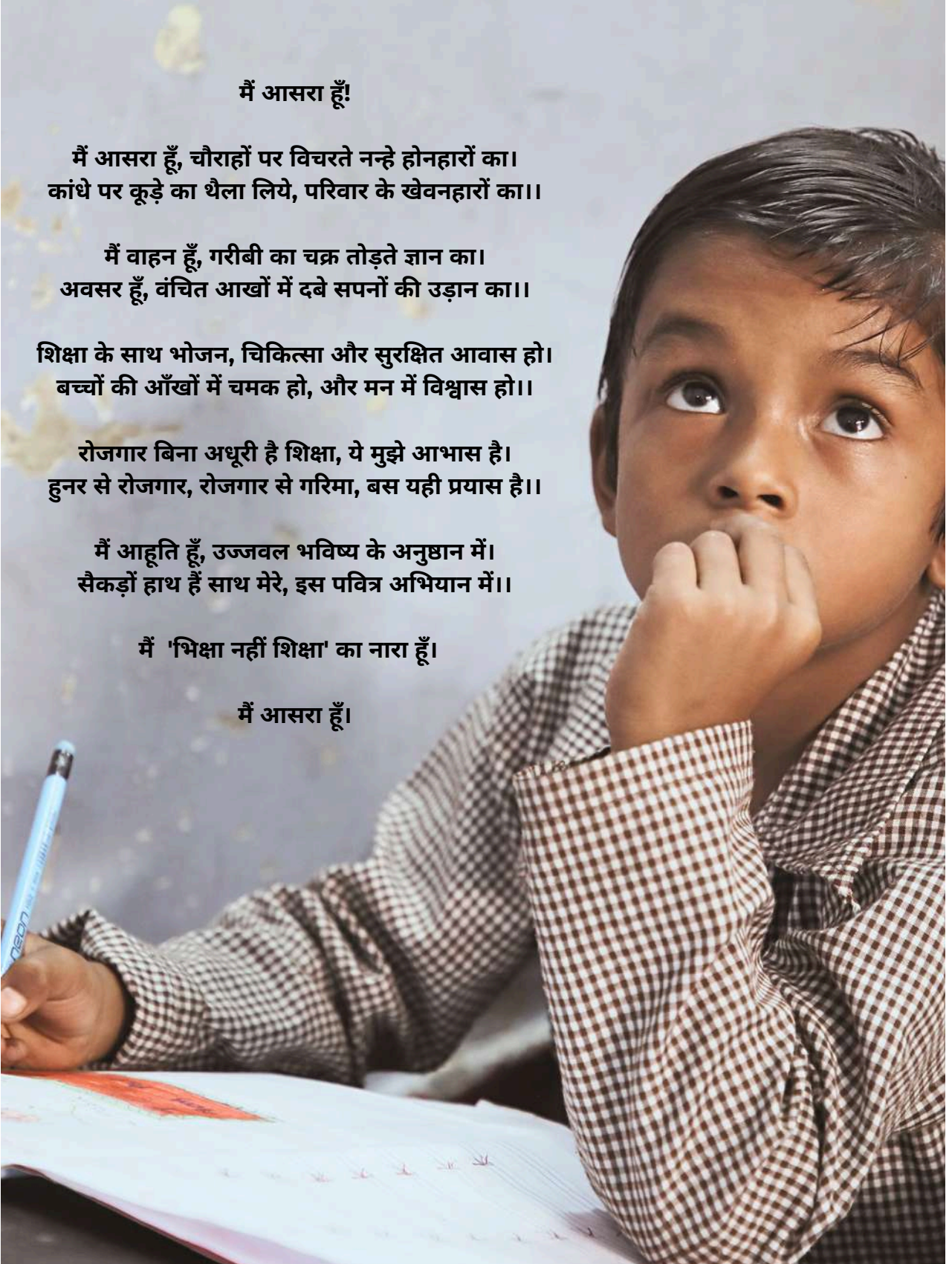

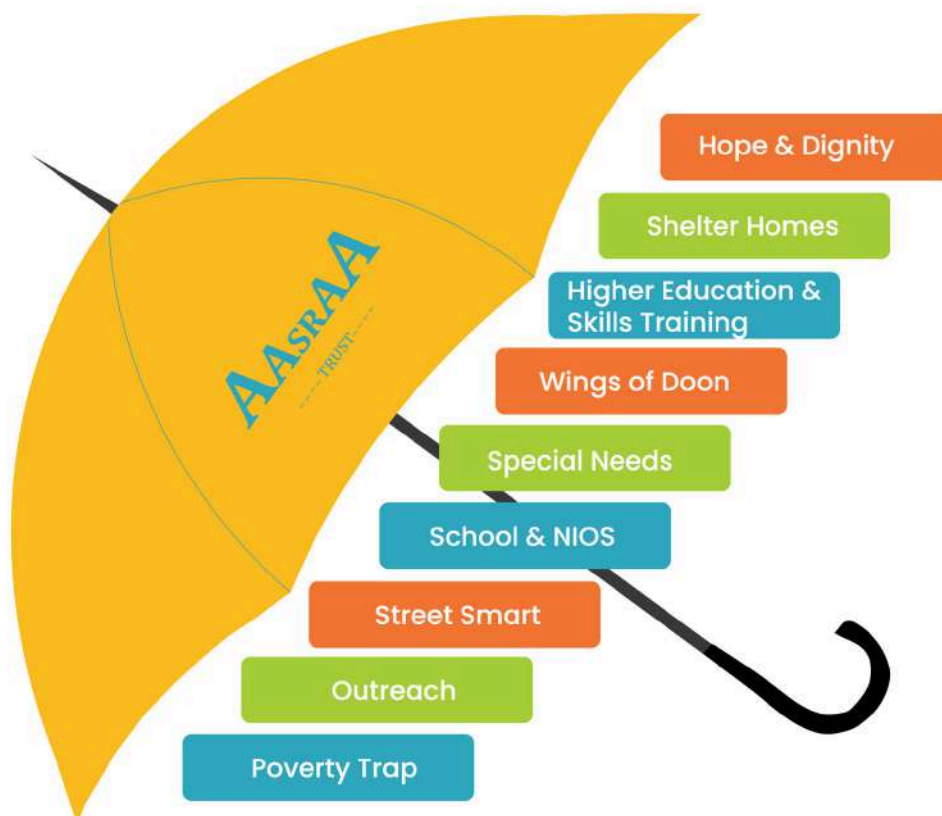

## SCHOOL QUALITY ENHANCEMENT PROGRAM WELCOMES 3 NEW SCHOOLS

Aasraa Trust, in collaboration with the Government of Uttarakhand, the Education Department, and The Education Alliance (TEA), has taken significant strides towards transforming the educational landscape in Dehradun, Uttarakhand, India.

One of the most exciting developments this year has been the expansion of SQEP, with the addition of three new government schools to our program, namely, Govt Primary School-Chander Road, Govt Upper Primary School-Chander Road, and Govt. Primary School, Shastri Nagar.

In these newly integrated schools, we are determined to make optimal use of the six hours of school time by incorporating extracurricular activities into the curriculum. This holistic approach to education ensures the overall development of each child, nurturing their skills and talents, and breaking the cycle of poverty through the power of education.

With our focus on infrastructure, teacher capacity building, improved pedagogy, and Computer-Aided Learning, we are determined to impact the learning levels of these deserving children.

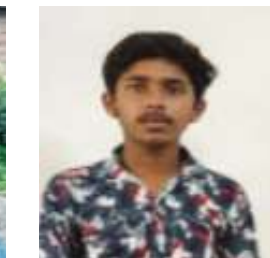

It ensures increased production of nutritious food, enhancing the health, attendance, and learning capabilities of the children in our care.

Beyond a mere kitchen, this facility symbolizes opportunity—a chance for these resilient children to break free from the shackles of their circumstances. With a nourished body and a nurtured spirit, they are now equipped to dream bigger, learn better, and thrive against all odds. The Multipurpose Hall, accompanying the kitchen, serves as a vibrant space for learning and self-discovery.

## COLLABORATION WITH THE EMBASSY OF JAPAN IN INDIA



Aasraa Trust had the privilege to collaborate with the Embassy of Japan in India for its innovative "Education on the Move" program. Through the Embassy's esteemed Grant Assistance for Grassroots Projects (GGP) scheme, "The Project for the Provision of Mobile Learning Bus" was meticulously chosen.



On 10th March 2022, we inked a Memorandum of Understanding (MoU), marking the beginning of a joint journey to uplift the lives of the underprivileged.

## GIRLS' SHELTER HOME

With the incredible support from help alliance, Aasraa is building a haven that can support 200 vulnerable girls.

The Shelter Home will ensure that the girls coming from slums, streets, abused backgrounds or disowned due to disabilities by their families have a place they can call home.

The girls will be provided with nutritious food and ever-ready medical care apart from education.

Aasraa will also support the mental and physical well-being of the girls and engage the children in healthy conversations.



## RESCUE OPERATION AT BHAUWALA

During a humanitarian intervention, Aasraa Trust swiftly responded to the devastating fire that swept through the Bhauwala Slum in April 2022, located 20 kilometers from Dehradun's town center. With great urgency, Team Aasraa mobilized and initiated an immediate relief effort to provide vital assistance to the affected children and their families.

Through this prompt and dedicated response, we were able to reach out to over 55 families, offering them essential goods and support crucial for their survival during this challenging time.



## THE TINKERING LAB

Our most exciting project – The Tinkering Lab is under construction. It will not just be a physical space but will symbolize a world of endless possibilities for the children of Aasraa Trust. Children will be encouraged to dream big, to question, and to embrace their natural curiosity. Through hands-on, do-it-yourself projects, they will embark on a journey of discovery, learning innovative skills that will shape their future in profound ways.

With immense gratitude, we extend our heartfelt thanks to ASED (Action for the Support of Deprived Children) and their esteemed Country Head, Ms. Sudha Parthasarathy, whose unstinted support gave us the push to start the construction of The Tinkering Lab.

## FROM CRISIS TO CARE: AASRAA'S COVID RELIEF 2.0 EFFORTS

**In the face of the relentless challenges brought on by the second wave of Covid-19, Aasraa Trust stood strong in its mission to empower the lives of the vulnerable members of our society.**

### Extending a Healing Hand Across 6 Districts:

Aasraa's Covid Relief 2.0 efforts reached far and wide, touching the lives of those in need across 6 districts of Uttarakhand. Our dedicated team distributed urgently needed medicines and equipment at 22 different locations in Dehradun, Tehri, Chamoli, Rudraprayag, Uttarkashi, and Pauri. Our commitment to healthcare went further as we supplied essential resources to 10 Community Health Centres, ensuring that medical facilities were well-equipped to tackle the crisis head-on.



### Nurturing Hope with Child Covid Care Units (CCUs):

Aasraa stepped up to establish two Child Covid Care Units (CCUs) in Chinyalisaur, Uttarkashi, and Pokhari, Chamoli. These specialized units were designed to provide comprehensive care and support to children affected by Covid-19, offering not just medical aid but also comfort and solace to the little ones and their families.

### The Silver Lining Project - Bridging the Educational Divide:

As schools closed their doors, Aasraa embraced innovation through "The Silver Lining Project", keeping our children connected to education despite the challenges. We distributed smartphones and tablets preloaded with e-learning and video calling apps, powered by Aasraa sponsored Sim Cards. **Witnessing the power of technology, 264 smart devices reached the hands of more than 2000 children, transcending barriers and fostering a love for learning.**



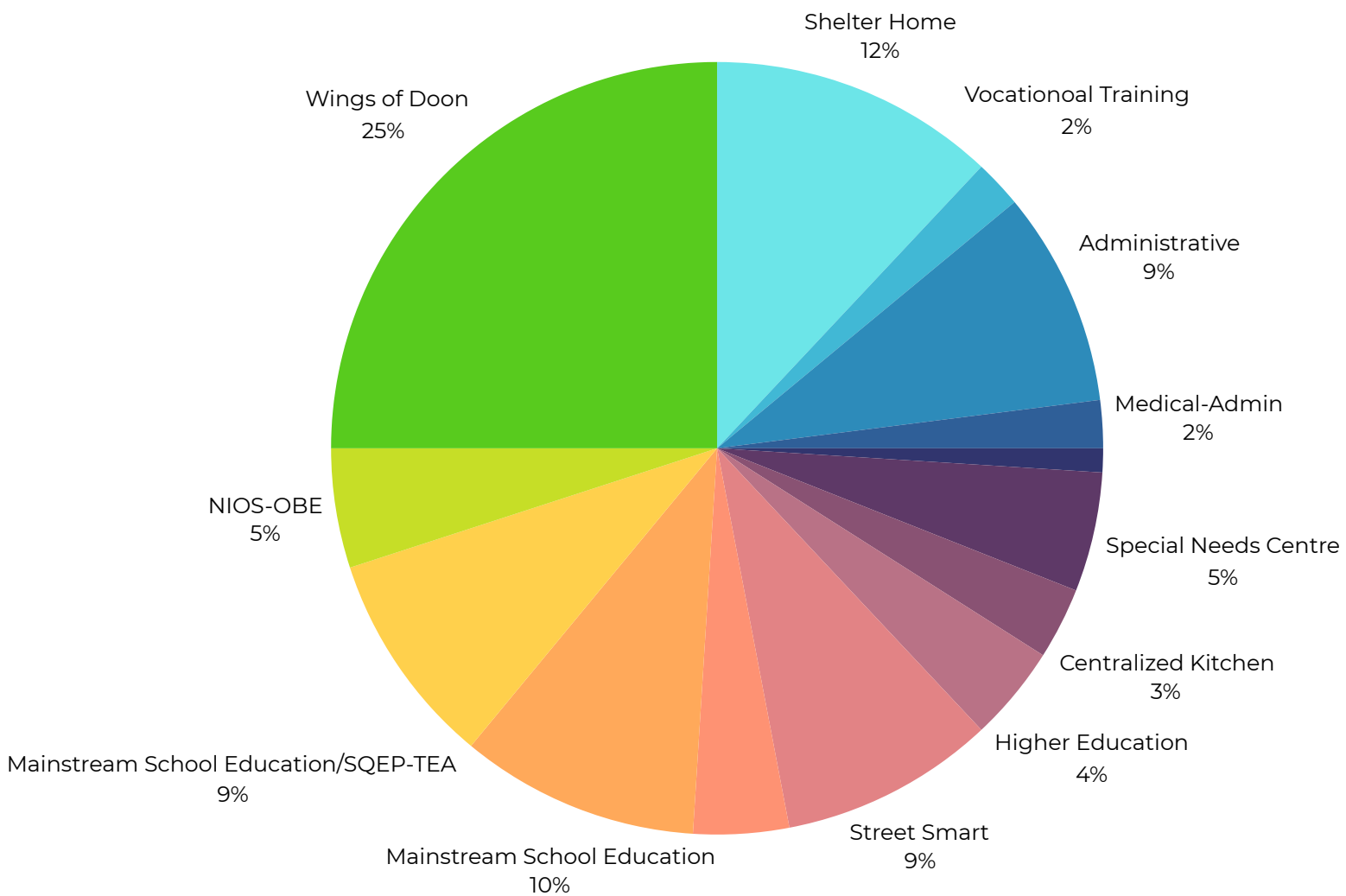

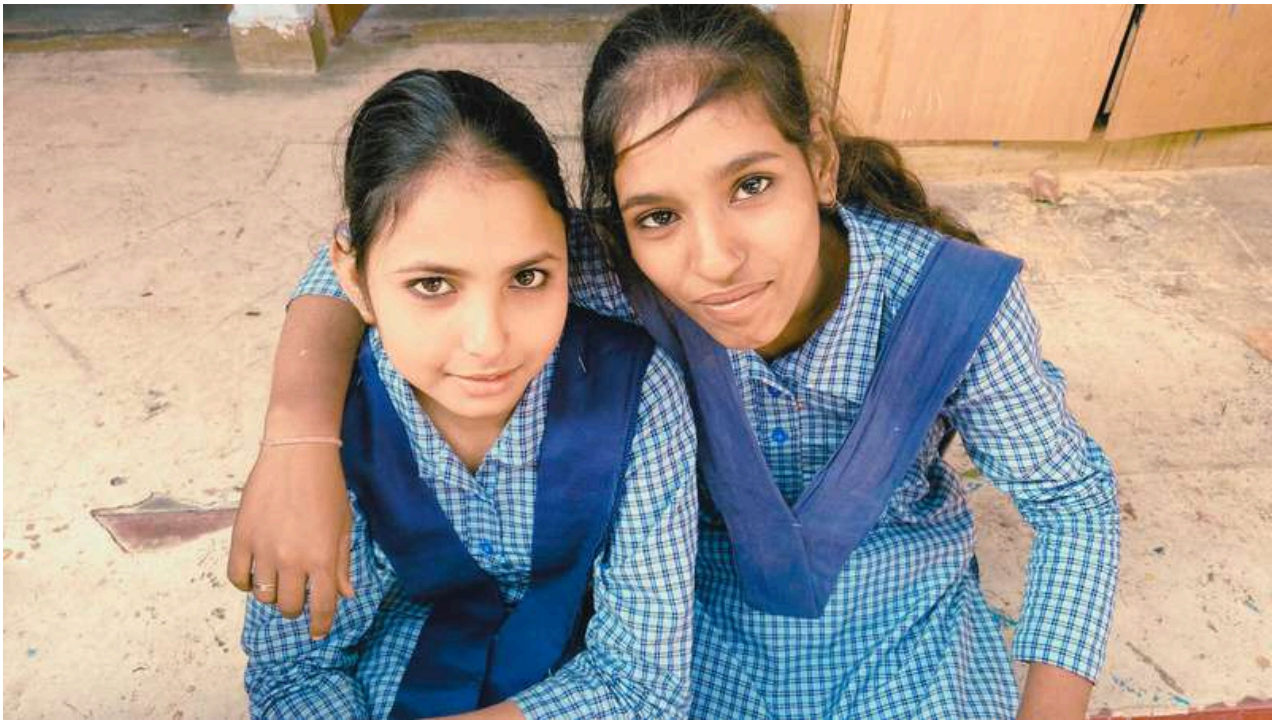
