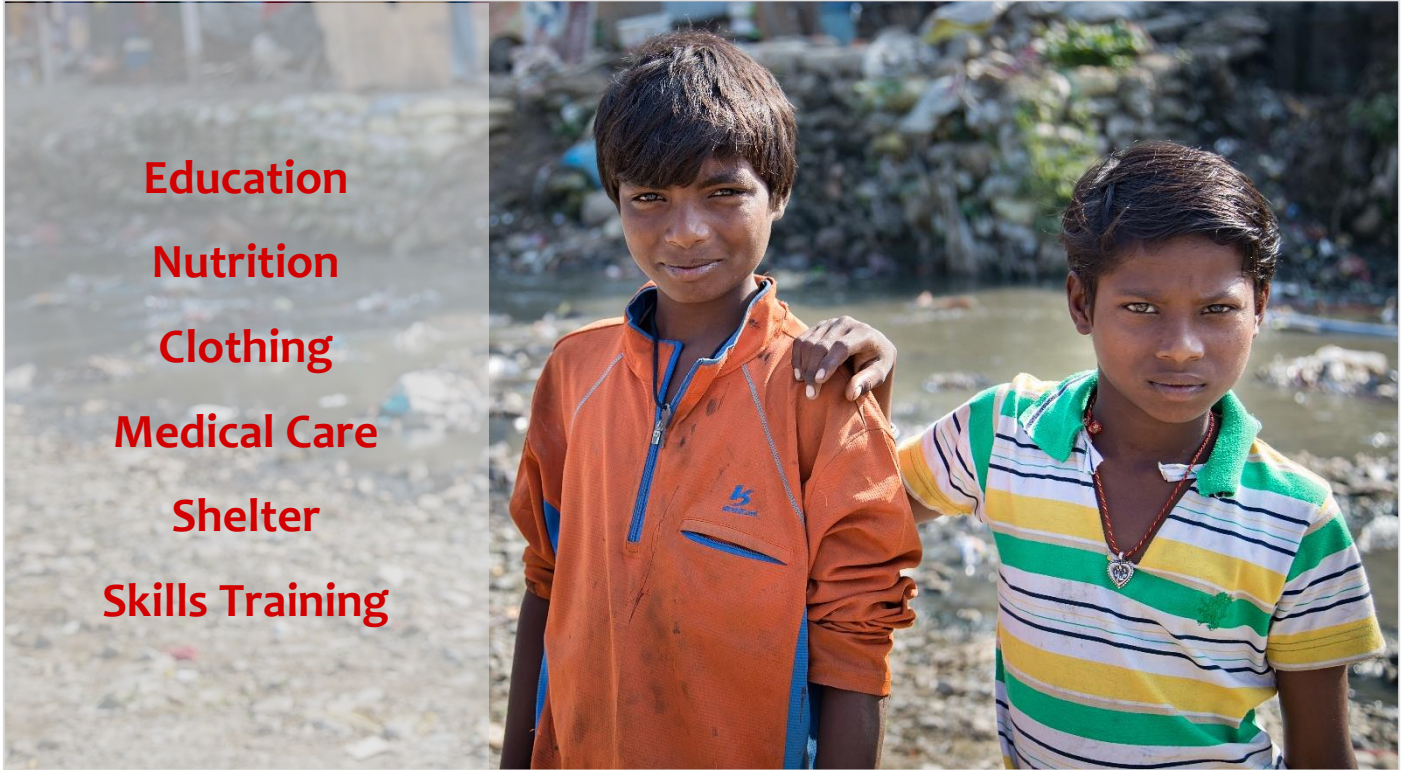

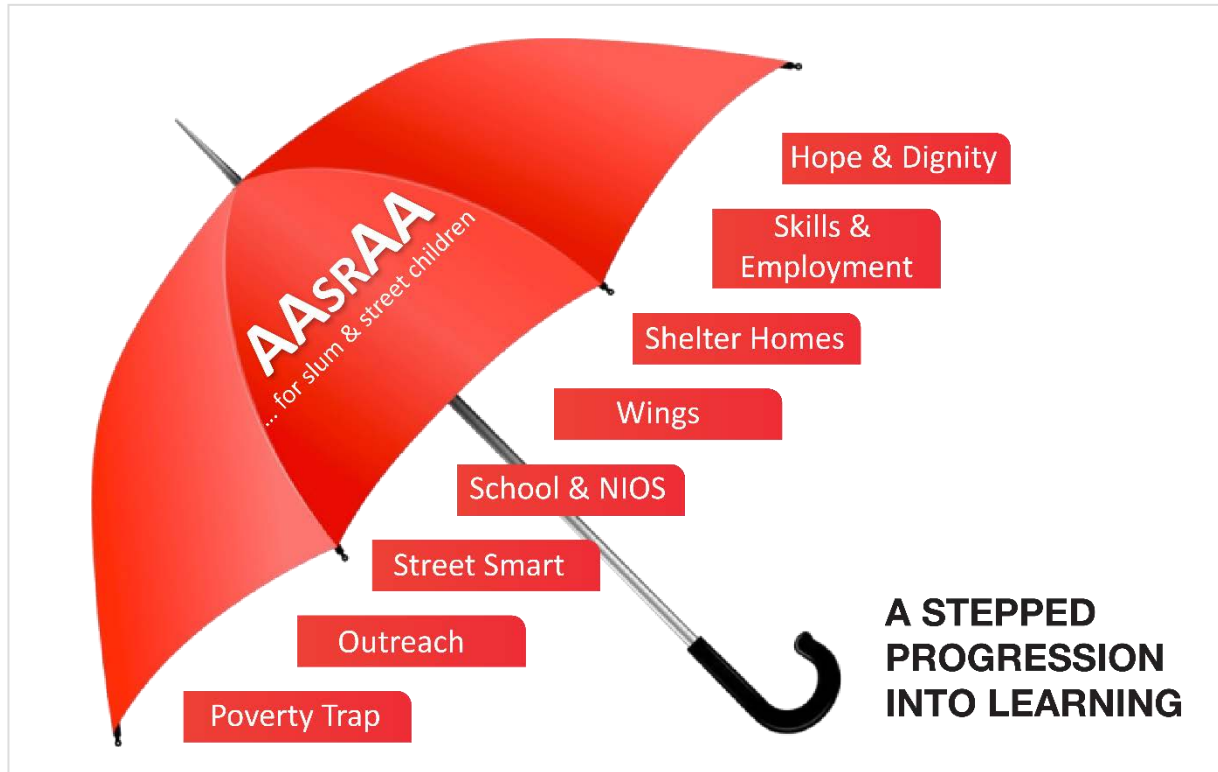

When our outreach team discovered about Shubham, we immediately took him under our care. His education became our responsibility. Our shelter home gave him the love and nourishment that he deserved.

Shubham is a first-generation learner in his family. With his sheer will and untiring hard work, he broke all shackles. He was on the state's honour list for class 10th. He is presently pursuing a Diploma in Mechanical Engineering.

In January 2019, he began his journey in the professional world with a month long apprenticeship at Padmini VNA Mechatronics, one of the leading manufacturers of advanced auto components for progressive automobile industry.
